JOURNEY'S END COMMUNITY DEVELOPMENT DISTRICT REGULAR BOARD MEETING NOVEMBER 8, 2023

A. CALL TO ORDER

District Manager Jason Pierman called the November 8, 2023, Regular Board Meeting of the Journey's End Community Development District (the "District") to order at 7:04 p.m. in the Conference Room at Journey's End Clubhouse located at 6400 Journey's End Drive, Lake Worth, Florida 33467.

B. PROOF OF PUBLICATION

Mr. Pierman presented proof of publication that notice of the Regular Board Meeting had been published in the *Palm Beach Post* on October 23, 2023, as part of the District's Fiscal Year 2023/2024 Meeting Schedule, as legally required.

C. ESTABLISH A QUORUM

Mr. Pierman determined that the attendance of Chairman Alex Da Costa, Vice Chairman Alfred Marten and Supervisor Glenn Siegel constituted a quorum.

Staff in attendance were: District Manager Jason Pierman of Special District Services, Inc.; and General Counsel Scott Cochran of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

Also present was District resident Peter Barica.

D. ADDITIONS OR DELETIONS TO AGENDA

There were no additions or deletions to the agenda.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. July 12, 2023, Public Hearing & Regular Board Meeting

Mr. Pierman presented the minutes of the July 12, 2023, Public Hearing & Regular Board Meeting and asked if there were any changes and/or additions.

There being no changes, a **motion** was made by Mr. Siegel, seconded by Mr. Marten and unanimously passed approving the minutes of the July 12, 2023, Public Hearing & Regular Board Meeting, as presented.

G. OLD BUSINESS

1. Update Regarding Lake Easement Encroachments

Mr. Barica stated that he had removed the pavers along the lake bank behind his house and then requested that he be allowed to keep the purple martin birdhouse where it is, explaining the importance of the birds. Following a brief discussion, a **motion** was made by Mr. Marten, seconded by Mr. Siegel and unanimously passed allowing Mr. Barica to keep the birdhouse, subject to an application, for which the fee would be waived.

2. Discussion Regarding Issues with Current Lake Maintenance Contract

Mr. Da Costa noted that the lake bank over-spraying had gotten better, but only because they were now not spraying close to the bank at all. Discussion ensued regarding the size of the littoral areas. Mr. Pierman stated that he would speak with Allstate about the state of the littoral areas.

3. Consider Superior Fence & Rail Estimate Proposal

Mr. Pierman explained that Ms. Rose-Gavars had reached out to Bulldog Fencing, on behalf of both the CDD and HOA, but could not get in touch with them. Mr. Da Costa stated that he would try to reach them and then bring back his findings to the January meeting. Mr. Pierman also noted that the clubhouse would be painted soon and that he was asking if the painters could paint the gates whilst onsite.

H. NEW BUSINESS

1. Consider Resolution No. 2023-05 – Adopting a Fiscal Year 2022/2023 Amended Budget

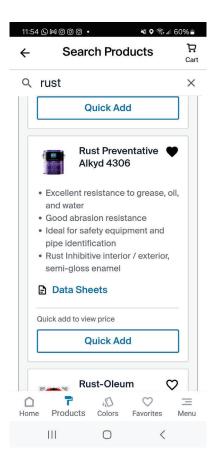
